Notification of the Consolidation of the Company's Subsidiaries in Thailand and Viet Nam

This is a notification that the Company has consolidated the following three previously non-consolidated subsidiaries from the first quarter of the fiscal year ending March 31, 2018.

1. Reasons for Consolidation

The Company is working to expand our business in the ASEAN region to support the "China + 1" needs of our customers as our group growth strategy for the future. The following three companies, which operate business in Thailand and Viet Nam under the umbrella of the Company's consolidated subsidiary of Nippon Manufacturing Service Corporation (100% owned by the Company), are planning to proceed with full-fledged business activities in the current term and these are becoming increasingly important. Therefore, we have decided to include them in our consolidated subsidiaries from the first quarter of the fiscal year ending March 31, 2018.
