Now Available on Google Play and the App Store in Korea

**TOKYO – March 24, 2022** – NEXON Co., Ltd. (Nexon) (3659.TO), a global leader in Virtual Worlds, today announced the highly anticipated launch of *Dungeon&Fighter Mobile* in Korea.



The launch marks a new milestone for *Dungeon&Fighter*, one of the world's most popular and successful entertainment franchises with more than 850 million registered players and over US\$18 billion in revenues since its debut in 2005.

The new game brings all the arcade action and fun of *Dungeon&Fighter* to mobile, the world's fastest growing game platform. Players begin by selecting a character on one of eight servers that can host a total of one million people simultaneously. There are five-character types including Ghost Knight, Fighter, Gunner, Mage and Priest. The game features duels against opponents involving [continuous skill attacks (combos)], plus complex raids with groups of six players.
