## 2. Reasons for the differences

Although net sales in the overseas market was lower than our expectation, overall net sales were basically in line with the original forecast because of the increase of sales of maintenance service and favorable sales in the retail & transportation market and the amusement market in Japan. Incomes exceeded the original forecast mainly due to such factors as improvements in the product mix and increase of sales of maintenance services in the overseas market, increase of sales of main products in the retail & transportation market and the amusement market in Japan as well as cost reduction.

The financial forecast for the full fiscal year ending March 31, 2020 announced on May 10, 2019 has not been revised.
