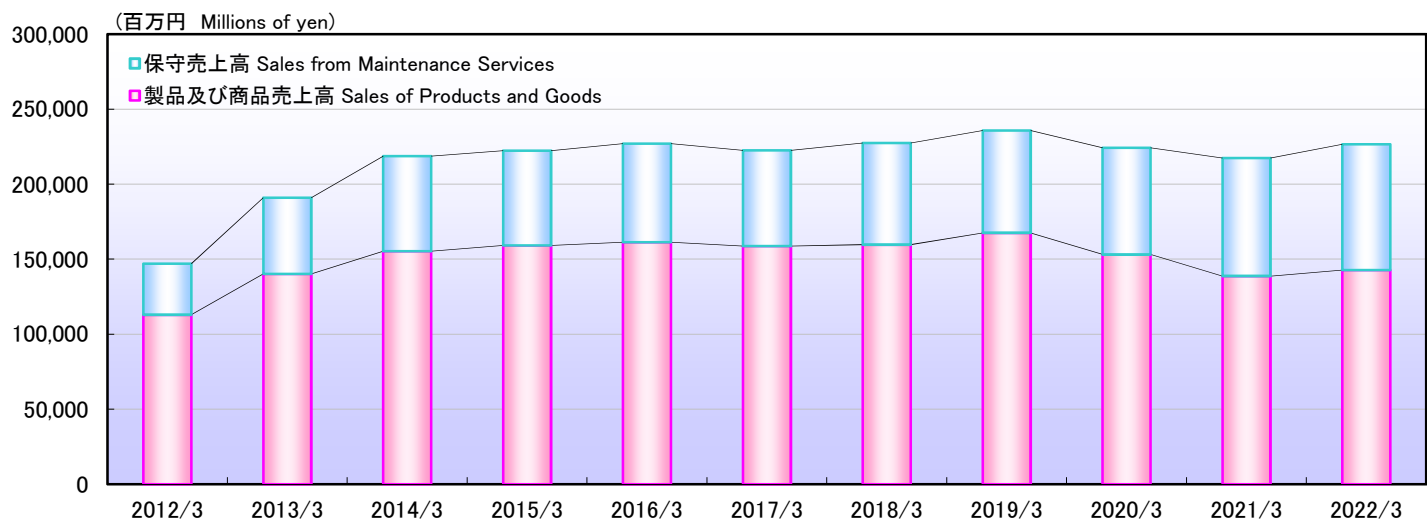

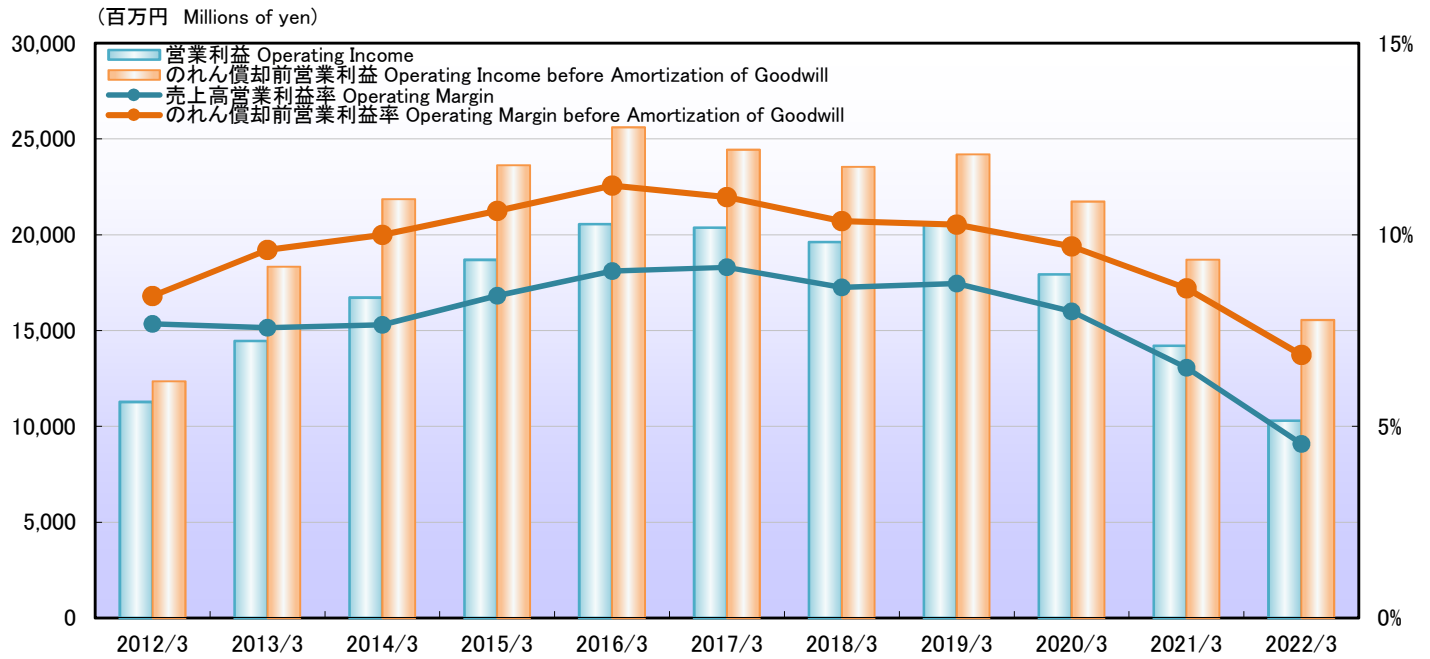

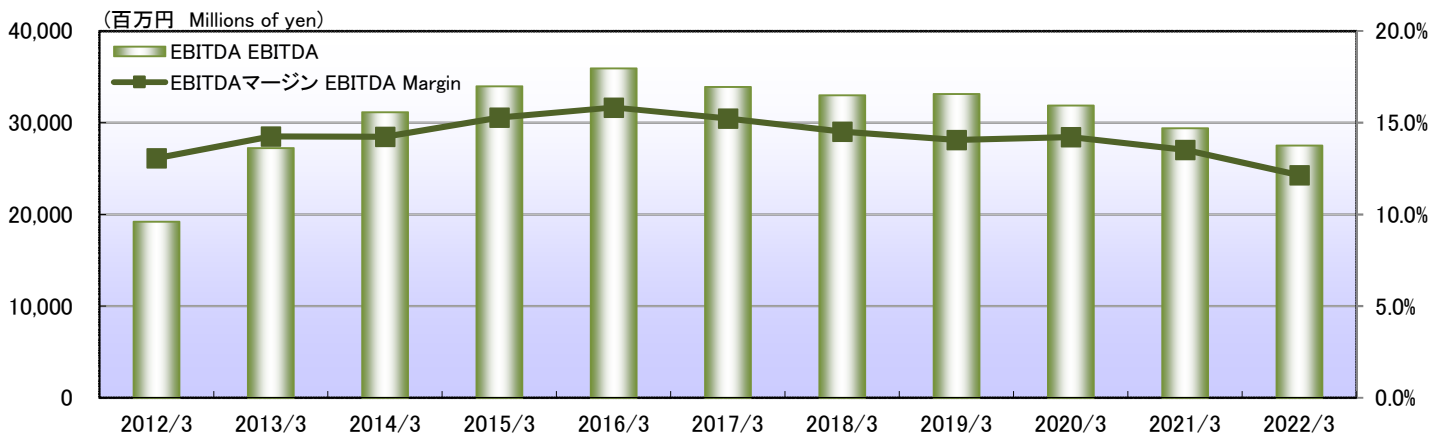

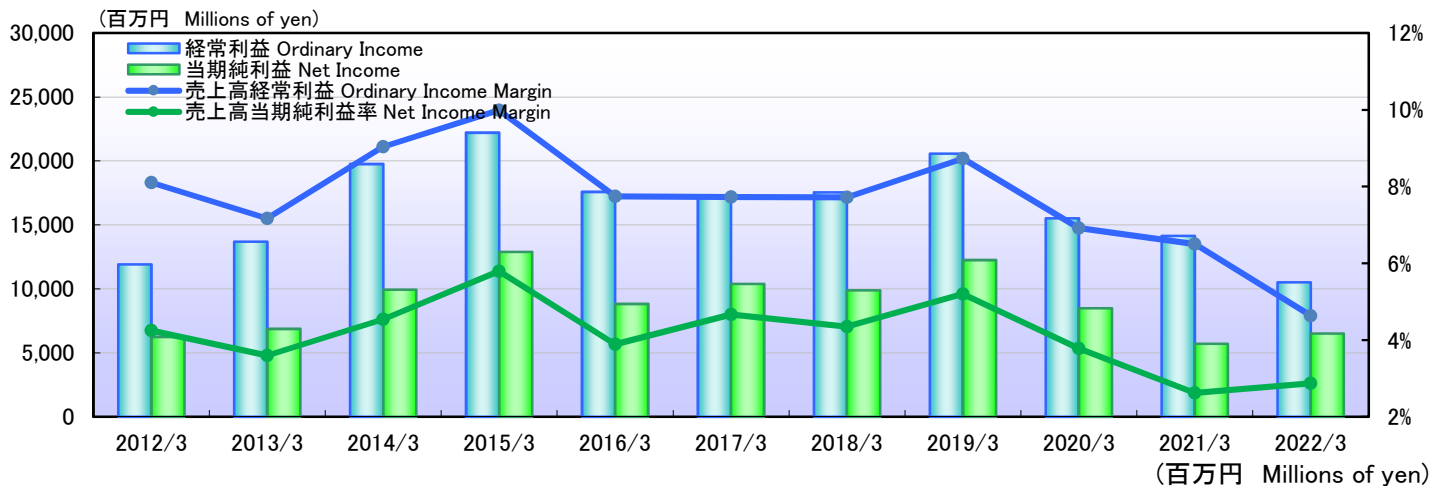

経常利益・当期純利益 Ordinary Income/Net Income



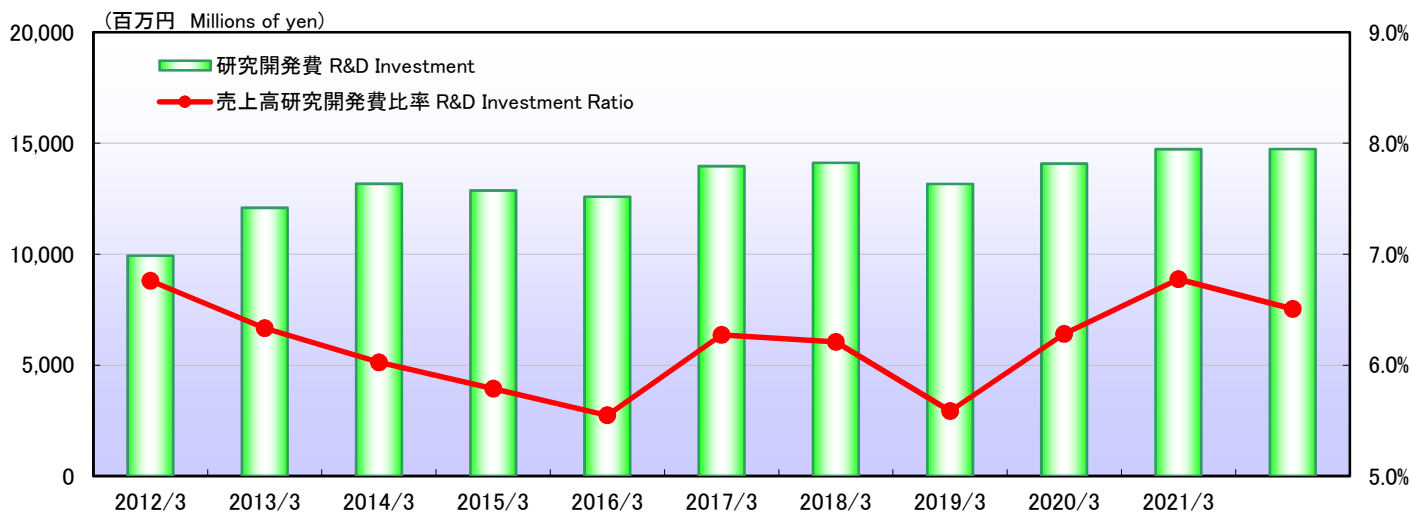

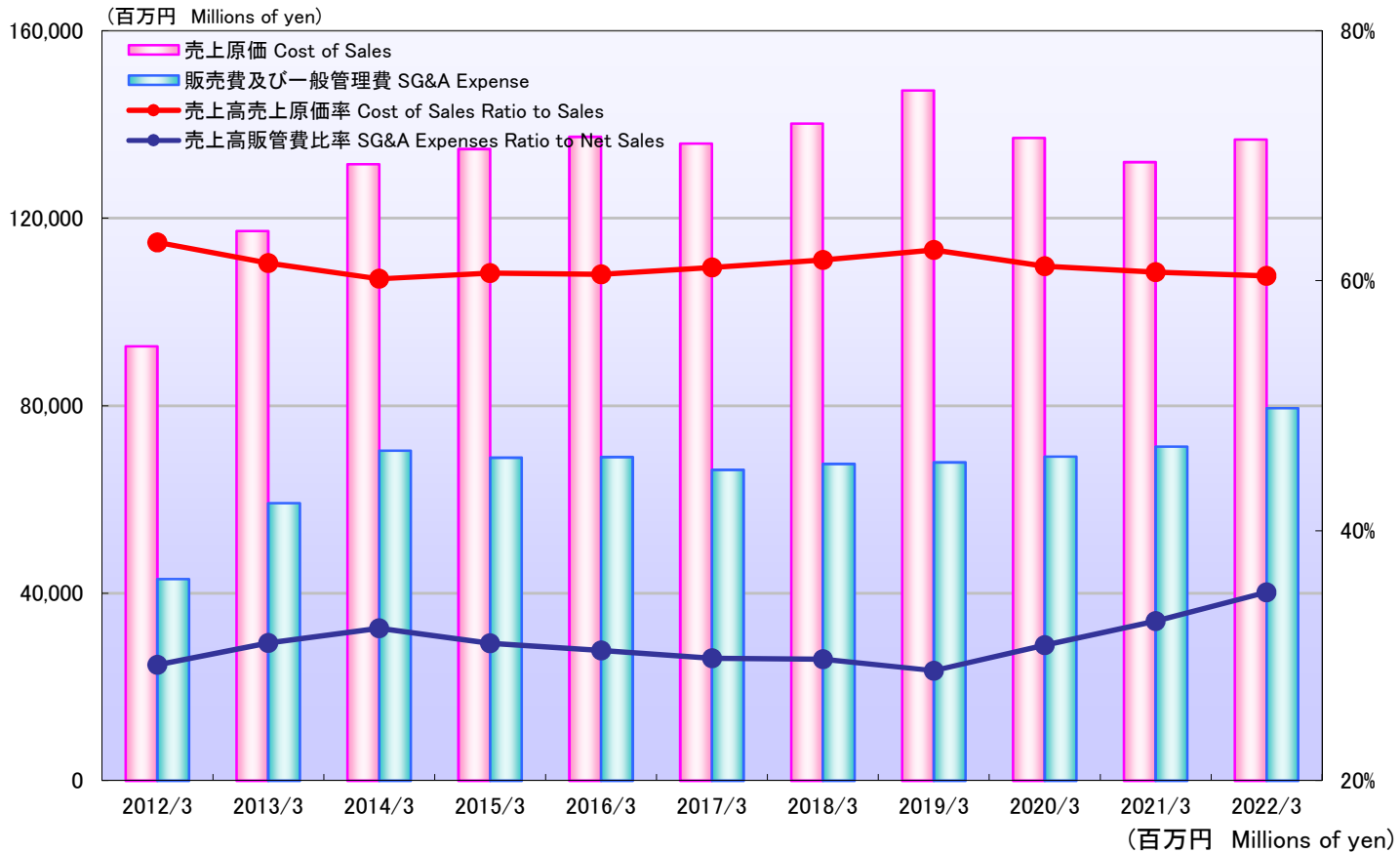

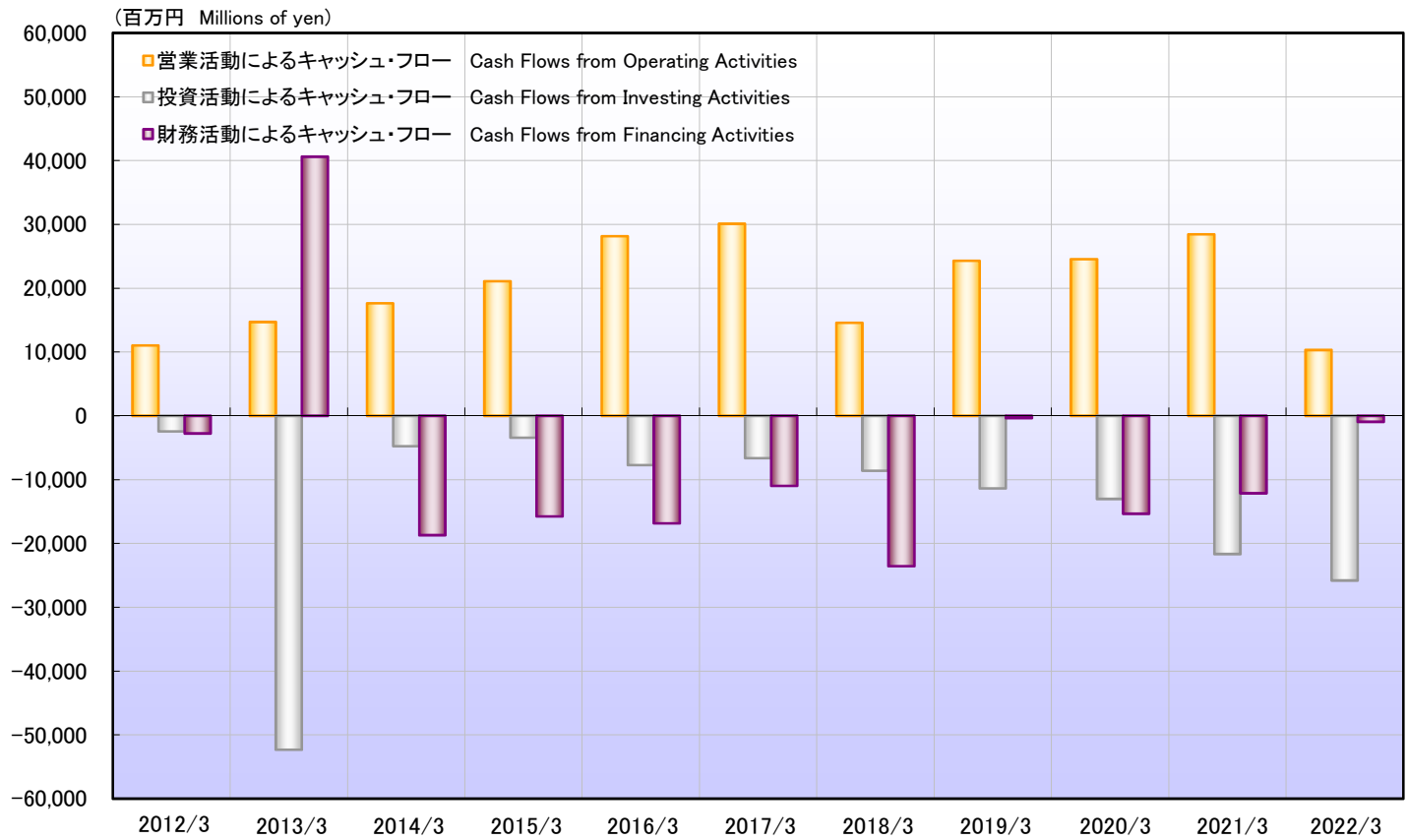

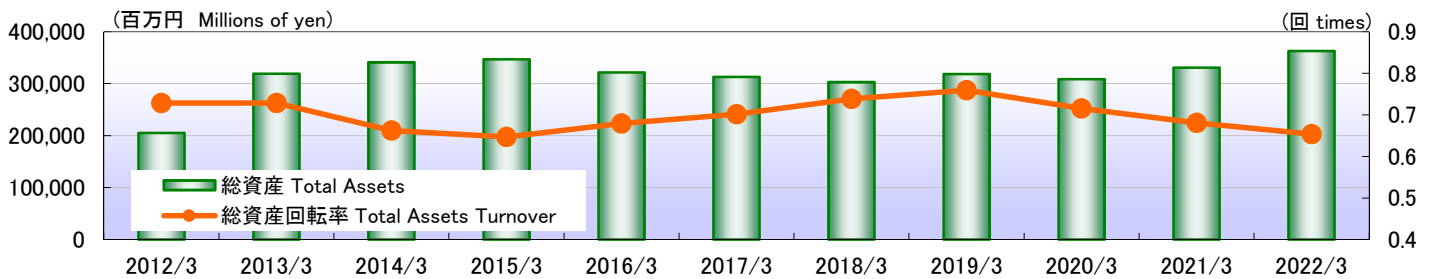

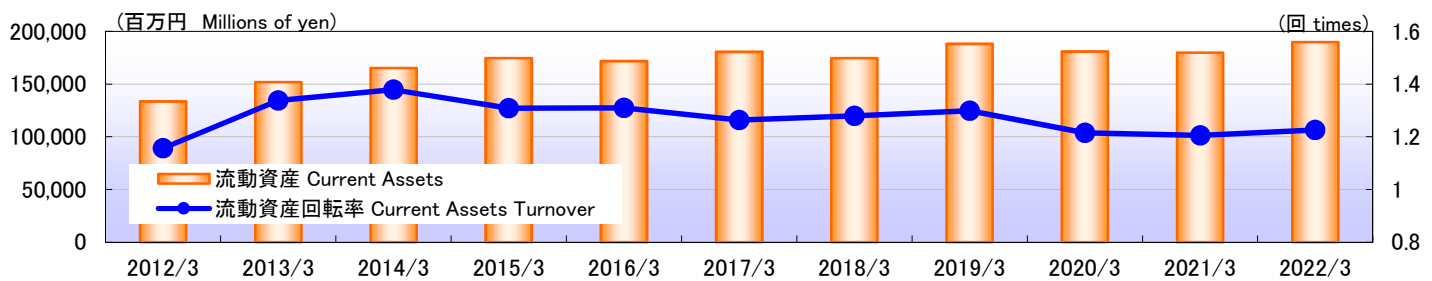

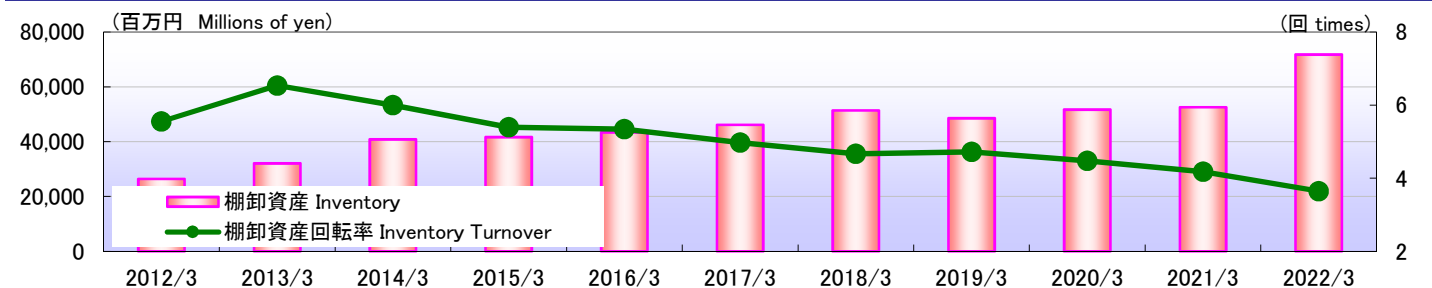

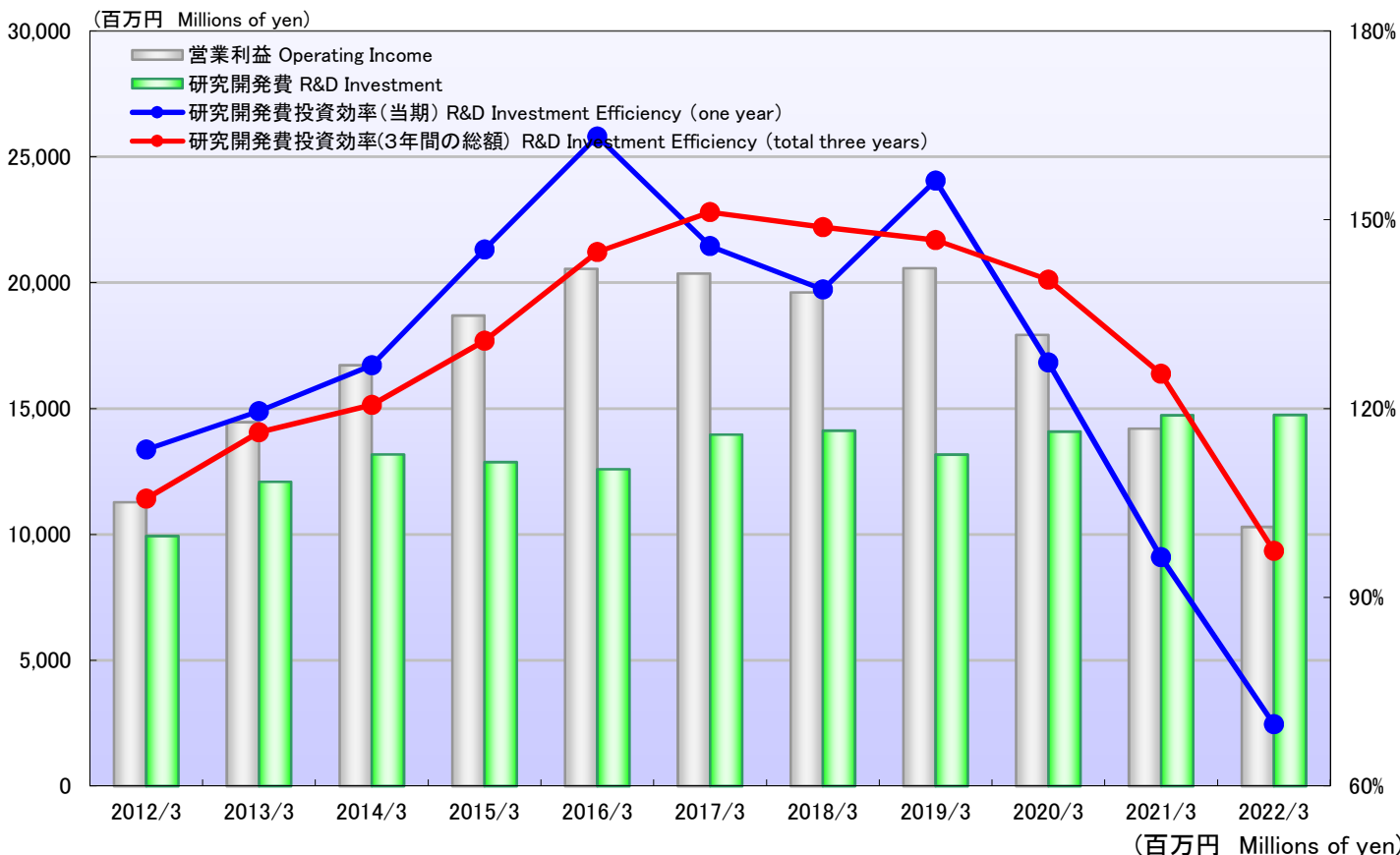

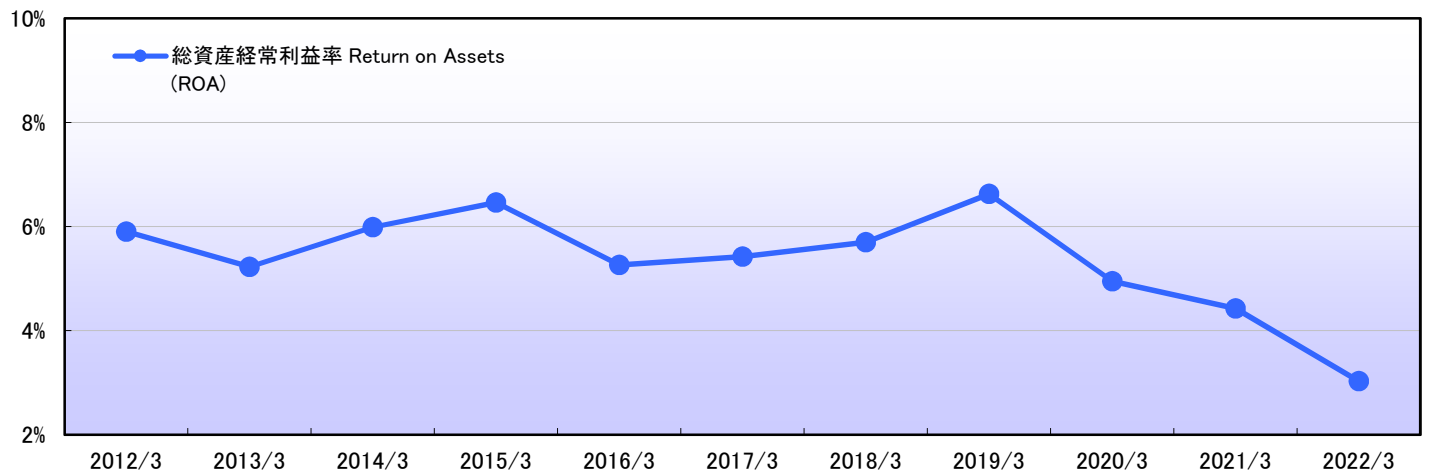

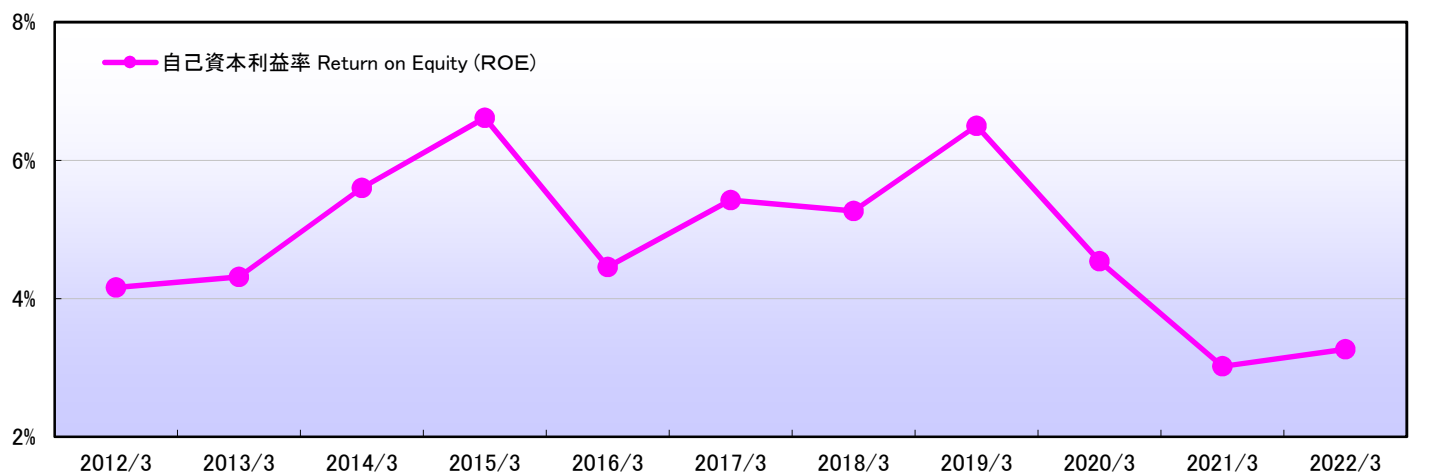

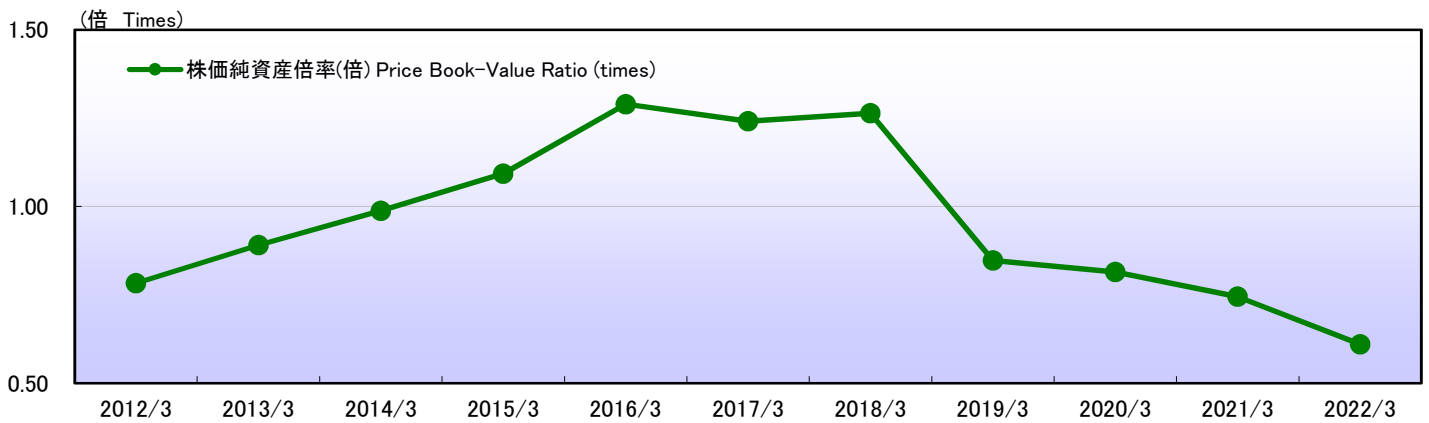

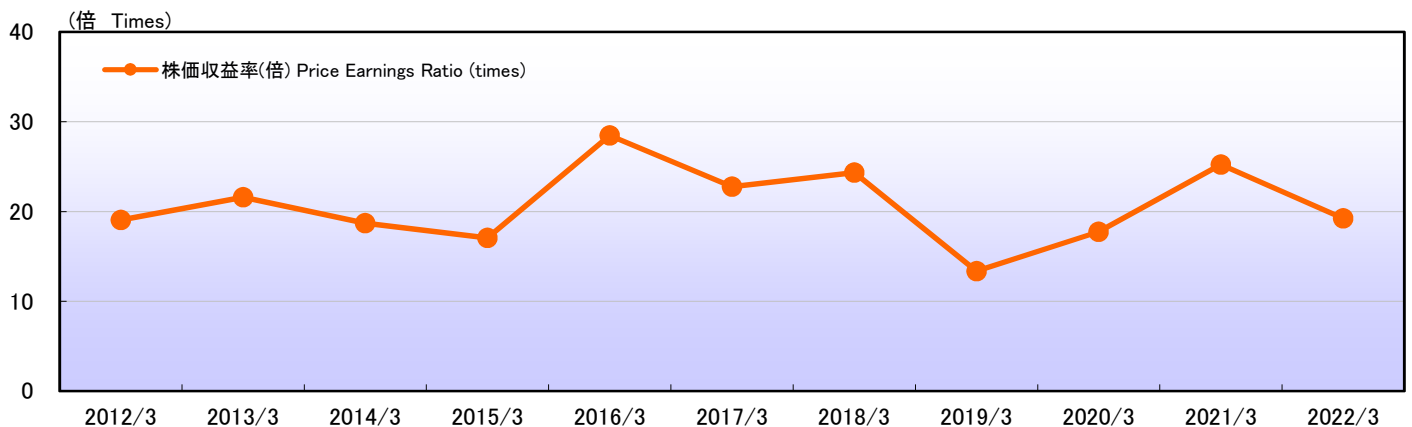

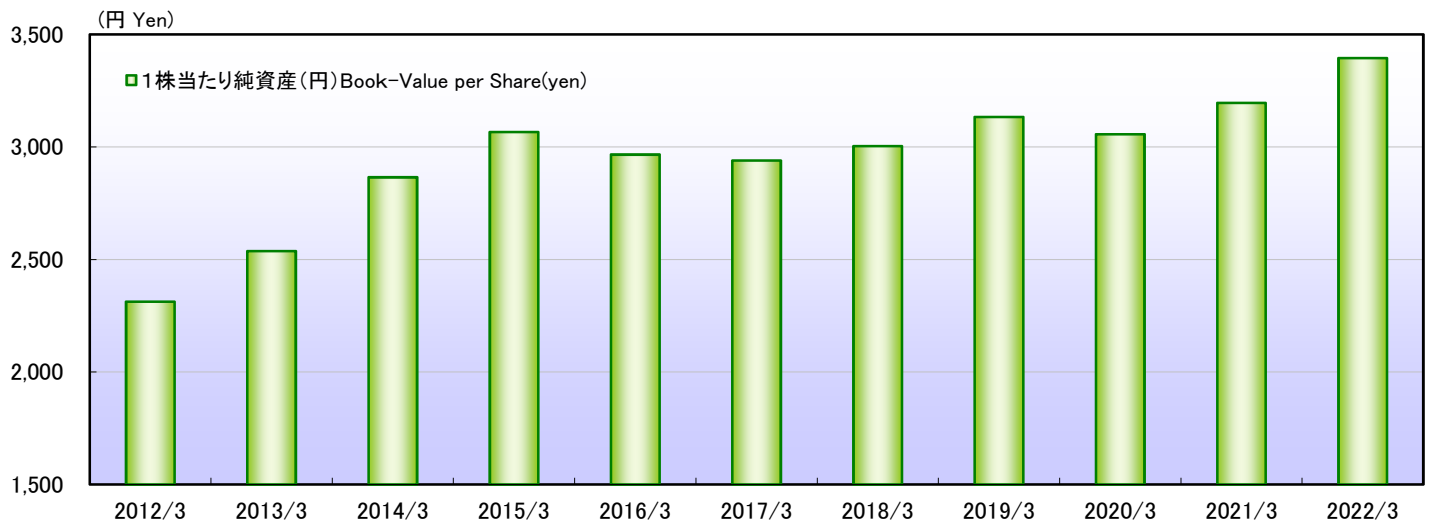

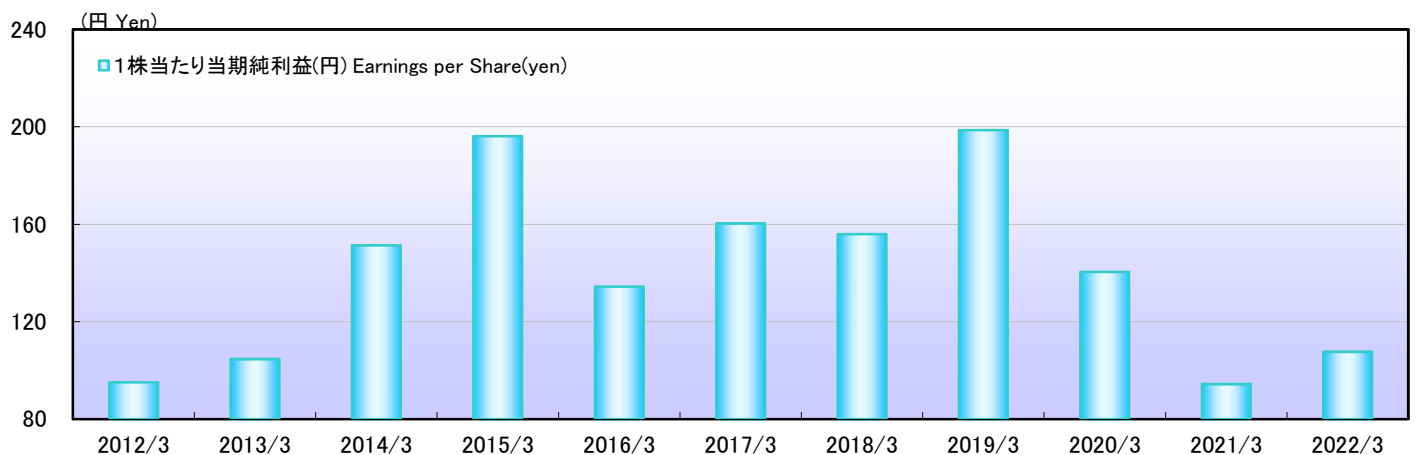

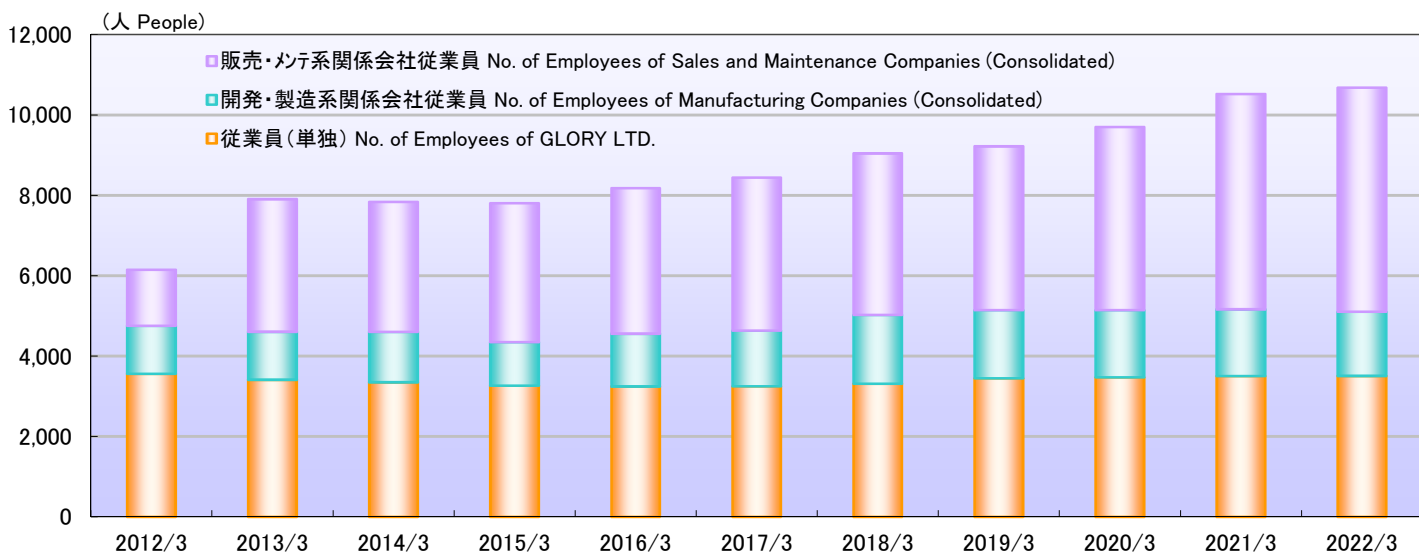

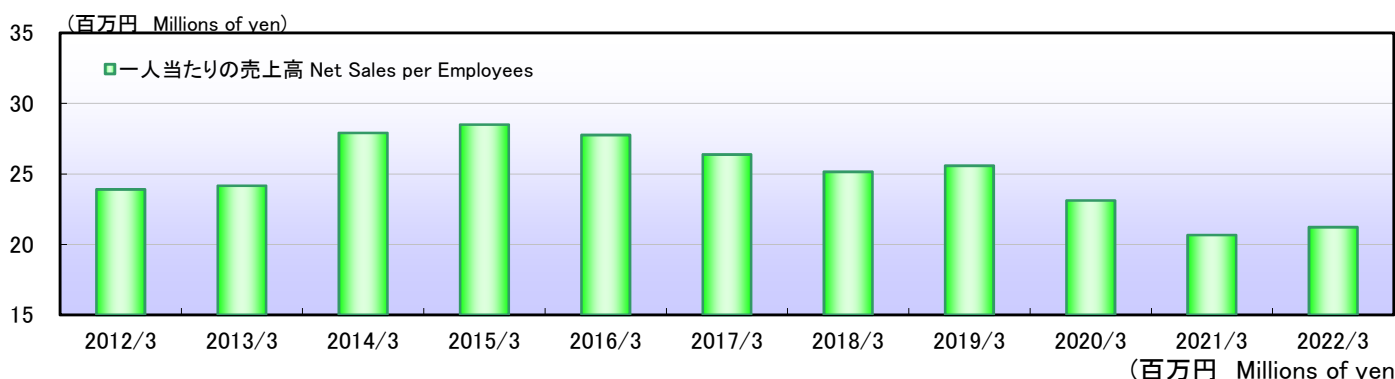

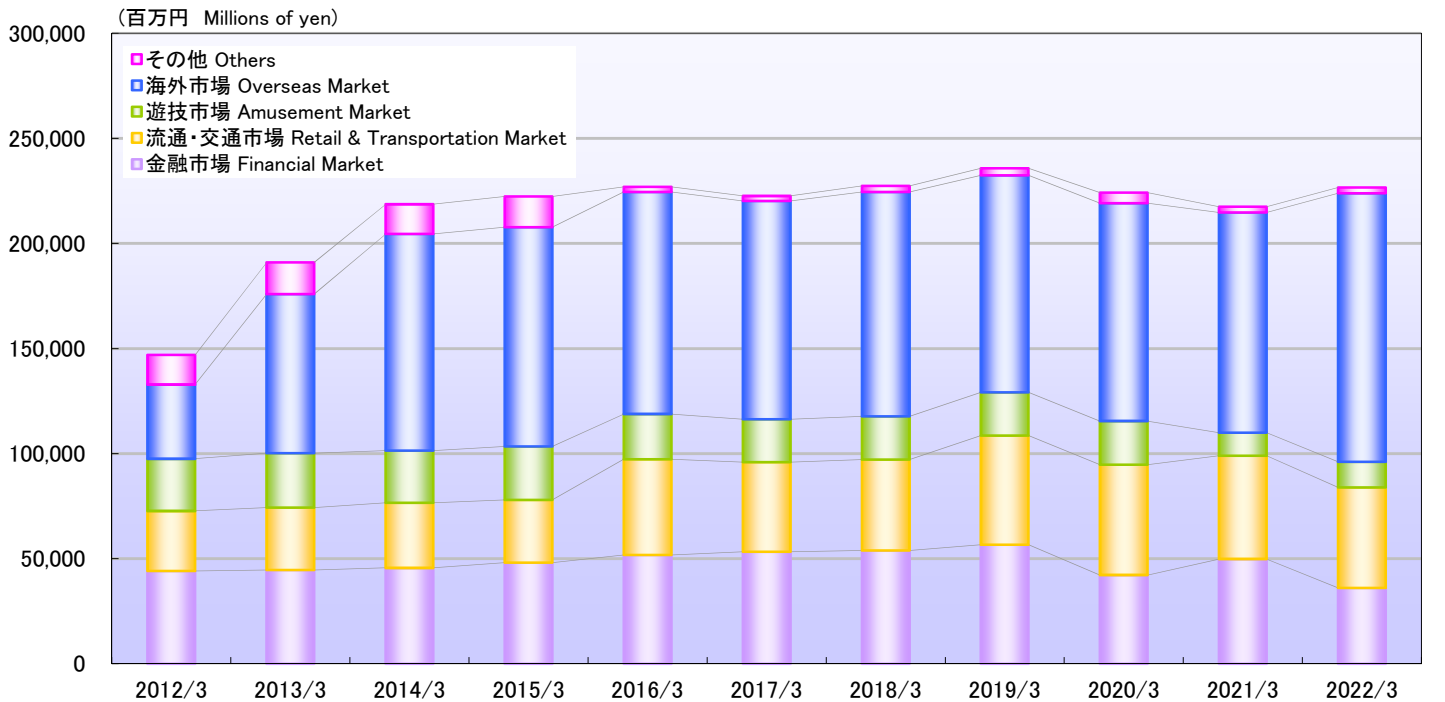
一人当たりの売上高 Net Sales per Employees

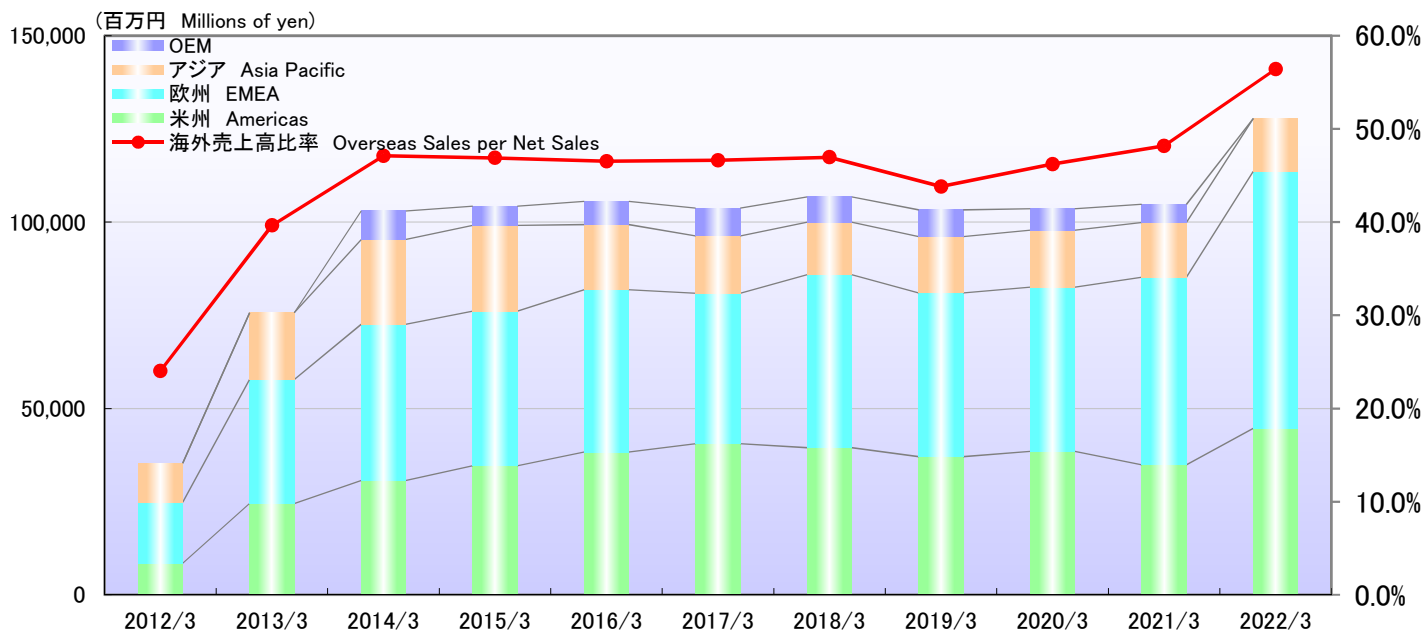
