Decision on Acquisition and Cancellation of Own Shares

GLORY LTD. (the “Company”) hereby announces that the Company’s Board of Directors made a decision on May 15, 2026 regarding acquisition of own shares pursuant to the provisions of Article 156 of the Companies Act, as applied *mutatis mutandis* pursuant to Article 165, paragraph (3) thereof. Furthermore, the Company decided to cancel the treasury shares in accordance with Article 178 of the Companies Act, as described below:

1. Reason for the acquisition and cancellation of own shares

Based on the target of achieving a “total return ratio of 100% or more” for the fiscal year ending March 31, 2027, as set forth in the “Basic Policy on Profit Distribution and Dividends”, the Company will implement the acquisition of its own shares. Furthermore, all of the shares acquired will be cancelled.

(2) Total number of shares to be acquired	4,000,000 shares (maximum) (7.4% of total shares issued, excluding treasury shares)

(5) Method of share acquisition	Market purchases on the Tokyo Stock Exchange
