◆ Technical Partnership with the Hangzhou Jinjiang Group for Large-Scale Polarizing Film

Nitto has entered into a technical partnership contract with Hangzhou Jinjiang Group Company Ltd. (Head Office: Hangzhou, China) and its affiliated companies, to provide technological support in response to increased demand in mainland China for large-scale polarizing film used in LCD TVs. Through this technical partnership, Nitto will assist the Hangzhou Jinjiang Group in introducing one of the world's largest front end polarizing film facilities in China.

Joint Development of Wireless Charging System for Hearing Instruments

Nitto and RION Co. Ltd. (headquarters: Kokubunji-shi, Tokyo) have developed the world's first *1 wireless charging system for hearing instruments. Consisting of a hearing instrument available through RIONET, rechargeable battery *2 that is interchangeable with the zinc-air battery generally used with hearing instruments, and wireless charger, the system provides users with dramatically greater convenience.

From November 12-19, Nitto ATP Finals was held at The O2 arena in London. Nitto successfully ended its first year as the title sponsor of the Nitto ATP Finals.
