## Approval of a Resolution for Acquisition of Treasury Shares

Tokyo (Wednesday, May 13, 2020) --- Shinsei Bank, Limited (“Shinsei Bank;” “the Bank”) today announced that, at its Board of Directors meeting held today, it approved a resolution for the acquisition of treasury shares. The approval of this acquisition of treasury shares is in accordance with the Bank’s Articles of Incorporation, pursuant to Article 459, Paragraph 1 of the Corporation Act.

### 1. Reason for Acquisition of Treasury Shares

As a part of the Bank’s efforts to achieve the repayment of public funds, a resolution to undertake the acquisition of treasury shares has been approved considering factors such as the Bank’s current capital position, earning capability and per share values. Through this acquisition of treasury shares, and along with maintaining sufficient level of capital, Shinsei Bank aims to increase the per share values through the implementation of an appropriate capital policy.
